10. APPLICATION FOR THE CONSIDERATION OF THE SUSPENSION/REVOCAION OF A HACKNEY CARRIAGE VEHICLE DRIVER'S LICENCE

The Director of Environment and Neighbourhood Services submitted a report asking the Sub-Committee to consider the application for the consideration of the suspension or revocation of a hackney carriage vehicle driver's licence.

A summary of the circumstances of the case was appended to the report.

MH was present at the meeting and was accompanied by Mr Feroz Khan, who addressed the Sub-Committee on his behalf, and Mr Zaheer Kayani.

Resolved -

That the hackney carriage vehicle driver's licence in respect of MH be revoked with effect from the end of 21 days' notice of the decision being give due to the Sub-Committee not considering him to be a fit and proper person to hold such a licence and due to the following reasonable causes pursuant to section 61 of the Local Government (Miscellaneous Provisions) Act 1976:

- (a) the nature of the offences, as detailed in the report;
- (b) insufficient time having elapsed since the offences were committed, as detailed in the report;
- (c) the breaches of licence conditions, traffic regulations and legislation, as detailed in the report;
- (d) concern over the safety of the public given the circumstances of the incidents;

- (e) that two similar incidents had occurred in short period of time, as detailed in the report.
